4) Your personal data is processed for the purpose of providing a service by road

electronically and personally in a stationary store, in particular, maintaining a customer account in a store, as well as concluding and executing sales contracts, including paying for purchased goods and rebates, delivery of goods, sending notifications about order fulfillment,

implementation of the complaint process and ensuring proper customer service,

matching the advertising offer to the clients' needs, advertising presentation and transmission

commercial information, handling notifications and complaints, expressing a public opinion about

purchased goods, allowing contact between buyers and sellers,

5) The legal basis for the processing of personal data may be expressed by

Your consent (Article 6 (1) (a) and the RODO), the need to take action on Pana /

a legitimate interest pursued by the administrator or by a third party
(Article 6 (1) (f) of the RODO). The legitimate interest of the administrator is

marketing, promotional and advertising,

6) Recipients of your personal data may be entities cooperating with
Administrator in performing the tasks specified in point 4, in particular
enterprises providing goods delivery services (couriers),
supporting processes necessary to send notifications about order fulfillment,
service providers providing advertising and marketing services, as well as in the field of
settlements of receivables,

7) Your personal data may be transferred to third countries, ie outside
European Economic Area (EEA) or international organizations, however
only to entities that provide adequate safeguards and
they guarantee the rights of data subjects and effective remedies. IN
this particularly includes the use of services provided by the Administrator
via Google and Facebook, in so far as it is necessary for the implementation
purposes indicated in point 4

8) Your personal data will be processed by the Administrator for a period of time
necessary to provide services or for other purposes indicated in point 4 above

9) You have the right to:

- requests from the Administrator to access their personal data,

- requests from the Administrator to correct their personal data,
- requests from the Administrator to remove or limit the processing of their data personal,
- filing an objection to the Administrator against the processing of personal data in the purpose of direct marketing,
- lodge an objection to the Administrator against profiling to the extent to which the processing is related to direct marketing,
- withdrawal of consent to the processing of your personal data,
- lodging a complaint to the supervisory body,

10) Please be advised that you do not have a statutory obligation to provide data personal data, however this obligation may arise from specific provisions.

The consequence of not providing personal data may in particular be missing the ability to provide services to your item, in particular the lack of opportunities conclusion of a contract for the sale of goods in an online store.
